2 Modifications to Clause 2, Normative references

Replace the 3rd entry with the following:

+ A1 2009 requirements"

Delete the entry for EN 60065.

Add the following new entries:

temperature (IEC 60068-2-14:2009)
EN 60068-2-75 1997 Environmental testing – Part 2-75: Tests – Test Eh: Hammer tests
(IEC 60068-2-75:1997)"

Delete the entry for EN 60950 series.

Delete the entry for EN 61000-6-3.
