Foreword

This document (EN 14468-1:2015) has been prepared by Technical Committee CEN/TC 136 "Sports, playground and other recreational facilities and equipment", the secretariat of which is held by DIN.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by September 2015, and conflicting national standards shall be withdrawn at the latest by September 2015.

Attention is drawn to the possibility that some of the elements of this document may be the subject of patent rights. CEN [and/or CENELEC] shall not be held responsible for identifying any or all such patent rights.

This document supersedes EN 14468-1:2004.

EN 14468 *Table tennis* consists of the following parts:

- *Part 1: Table tennis tables, functional and safety requirements, test methods*
- *Part 2: Posts for net assemblies, Requirements and test methods*

In relation to EN 14468-1:2004 the following main amendments have been made:

- a) new terms were added;
- b) in 5.1 "Dimensions", new figures with the title "Parts under the heights of cross braces" were added;
- c) in Table 3 "Dimensions related to the tabletop and the undercarriage of Classes A to D", new dimensions were added;
- d) in 5.3.1, requirements for material were added;
- e) in 5.3.6.2 "frame reinforcements", the requirement for wheelchair table tennis was deleted;
- f) in Clause 5 "Functional requirements", new subclauses "5.6 Residual height reduction" and "5.8 Additional requirements for tables for wheelchair play" were added;
- g) in Clause 6 "Safety requirements", new subclauses "6.1.1 General", "6.1.4 Safety area", "6.8 Table finish" and "6.9 Additional parts" were added;
- h) in 6.3.1.1 "Storage position of the tabletop", new requirements were added;
- i) in 6.3.1.1, Table 6 "Locking devices and unlocking actions" was added;
- j) in Clause 7 "Test methods", 7.1 "General" was updated;
- k) in Clause 7, 7.4 "Ball bounce", a new requirement was added;
- l) Clause 8 "Environmental aspects" was added;
- m) a new figure was added in Clause 10 "Marking";
- n) new Annex A "Optional pendulum test" was added.

1 Scope

This European Standard specifies functional requirements (see Clause 5) and safety requirements (see Clause 6) for table tennis tables hereafter referred to as tables. They are applicable for tables used only for playing table tennis and take no account of the consequences of any misuse.

This European Standard is applicable to five types of tables (see Table 2) within the Classes A to D (see Table 1).

This European Standard excludes table tennis tables which are installed in locations covered by EN 1176 and EN 15312.
