This document (EN 50571:2013/A1:2018) has been prepared by CLC/TC 61, "Safety of household and similar electrical appliances".

The following dates are fixed:

- latest date by which this document has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2018-07-12
- latest date by which the national standards conflicting with this document have to be withdrawn (dow) 2021-01-12

This amendment supplements or modifies the corresponding clauses of EN 60335-1:2012 including its amendments and EN 50571:2013.

EN 50571:2013/A1:2018 is to be read in conjunction with EN 60335-1:2012 and A11:2014, A12:2017, A13:2017, A1:201X, A14:201X, which is referred to in this text as "Part 1".

NOTE The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.

This document has been prepared under a mandate given to CENELEC by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive.

For the relationship with EU Directive see informative Annex ZZ, included in EN 50571:2013.

## 1 Scope

Replace the 2<sup>nd</sup> sentence of the 2<sup>nd</sup> paragraph to read:

“.....**washing machines** which are declared for commercial use in an **area open to the public** and operated by lay persons e.g. in laundrettes, ...”

Replace the 8<sup>th</sup> paragraph to read:

“This European Standard does not apply to

- a) industrial laundry machinery with a drum volume > 150 l (EN ISO 10472-2),
- b) **washing machines** intended .....
