## 1 Modification to the Scope

*Replace Note 101 by the following:*

NOTE Z101 Examples of appliances that are within the scope of the standard are

- **ultrasonic humidifier,**
- **impeller humidifier,**
- **evaporation humidifier,**
- **steam vaporizer humidifier.**

*Replace the fourth paragraph including the two dashed items by the following:*

This standard deals with the reasonably foreseeable hazards presented by appliances and machines that are encountered by all persons. However, in general, it does not take into account

- **children** playing with the appliance,
- the use of the appliance by **very young children**,
- the use of the appliance by **young children** without supervision.

It is recognized that **very vulnerable people** may have needs beyond the level addressed in this standard.
