INTRODUCTION

This part of IEC 60317 forms an element of a series of standards which deals with insulated wires used for windings in electrical equipment. It is composed of the following series:

- 1) *Winding wires – Test methods* (IEC 60851 series);
- 2) *Specifications for particular types of winding wires* (IEC 60317 series);
- 3) *Packaging of winding wires* (IEC 60264 series).

SPECIFICATIONS FOR PARTICULAR TYPES OF WINDING WIRES –

Part 84: Polyesterimide enamelled round copper wire, class 200

1 Scope

This part of IEC 60317 specifies the requirements of enamelled round copper winding wires of class 200 with a sole coating based on polyesterimide resin, which may be modified providing it retains the chemical identity of the original resin and meets all specified wire requirements.

NOTE A modified resin is a resin that has undergone a chemical change or contains one or more additives to enhance certain performance or application characteristics.

The range of nominal conductor diameters covered by this document is as follows:

- Grade 1: 0,018 mm up to and including 3,150 mm;
- Grade 2: 0,020 mm up to and including 5,000 mm;
- Grade 3: 0,0250 mm up to and including 1,600 mm.

The nominal conductor diameters are specified in Clause 4 of IEC 60317-0-1:2013.
