1 Scope

This clause of Part 1 is applicable, except as follows.

Addition:

This document applies to **grass shears** with a maximum **cutting width** of 200 mm designed primarily for cutting grass.

This document does not apply to hedge trimmers.

NOTE 101 Hedge trimmers are covered by IEC 62841-4-2.
