1 Scope

This document specifies

- metrological requirements,
- maximum permissible errors,
- requirements for marking and
- information to be provided for users,

for dilutors with a sample uptake capacity (In) from 5 μ l to 1 ml and a diluent capacity (Ex) from 50 μ l to 100 ml. They are designed to deliver the sample and diluent together in measured proportion and measured volume.
