2 Modification to Clause 1, "Scope"

Replace the fifth paragraph, excluding Notes 101 and 102, starting from "As far as is practicable ..." up to "- children playing with the appliance by young children" by the following:

This document deals with the reasonably foreseeable hazards presented by appliances and machines that are encountered by all persons. However, in general, it does not take into account:

- **children** playing with the appliance;
- the use of the appliance by **young children** and **very young children**;
- the use of the appliance by **older children** without supervision.

It is recognized that **very vulnerable people** may have needs beyond the level addressed in this document.

Replace NOTE references of Note Z1, Z2 and Z3 by Note Z101, Z102 and Z103.
