Delete the EN addition.

Addition:

“This amendment supplements or modifies the corresponding clauses of the standards below:

- EN 60335-1:2012+A11:2014+A13:2017+A1:2019+A14:2019+A2:2019 (Part 1)
- EN 60335-2-8:2015+A1:2016+A2:2022 (Part 2)”

2 Modification to the Scope

Replace the paragraph starting with “This standard deals with the reasonably foreseeable hazards... level addressed in this standard”, except Note Z105 and Note Z106, with the following:

“This document deals with the reasonably foreseeable hazards presented by appliances that are encountered by all persons in and around the installation place. However, in general, it does not take into account:

- **children** playing with the appliance;
- the use of the appliances by **young** and **very young children**;
- the use of shaver, wet shaver, animal clipper, hair clipper, and appliances for manicure and pedicure by **older children** without supervision;
- the use of **animal shearer** by non-trained personnel.

It is recognized that **very vulnerable people** can have needs beyond the level addressed in this document.”
