2 Modification to Clause 1, “Scope”

Replace the text starting with “Appliances not intended for normal...” and ending in “... Children playing with the appliance.” by the following:

Appliances intended to be used by laymen in shops and other premises for normal housekeeping purposes, are within the scope of this document.

NOTE Z101 Examples of appliances for household environment are appliances for typical housekeeping functions used in the household environment that can also be used by non-expert users for typical housekeeping functions:

- in shops and other similar working environments;
- in farm houses;
- by clients in hotels, motels and other residential type environments;
- in bed and breakfast type environments.

NOTE Z102 Household environments include the dwelling and its associated buildings, the garden, etc.

As far as is practicable, this document deals with the common hazards presented by appliances that are encountered by all persons in household and similar environments.

However, in general, it does not take into account

- **children** playing with the appliance,
- the use of the appliance by **very young children**,
- the use of the appliance by **young children** without supervision.

It is recognized that **very vulnerable people** can have needs beyond the level addressed in this document.
