With European Amendment A11 the EN 60335-2-4:2010+A1:2015+A11:2018+A2:2019 is superseded.

This European Amendment A11 supplements or modifies the corresponding clauses of the standards below:

- EN 60335-1:2012+A11:2014+A13:2017+A1:2019+A14:2019+A2:2019+A15:2021+A16:2023 (Part 1)
- EN IEC 60335-2-4:2023 (Part 2)

2 Modification to the “Scope”

Replace the text starting with “As far as is practicable...” up to “...explosive atmosphere (dust, vapour or gas)” by the following:

“This document deals with the reasonably foreseeable hazards presented by appliances that are encountered by all persons.

However, in general, it does not take into account:

- **children** playing with the appliance;
- the use of the appliance by **very young children**;
- the use of the appliance by **young children** without supervision.

It is recognized that **very vulnerable people** can have needs beyond the level addressed in this document.

This document does not apply to

- **spin extractors** intended to be used in launderettes (EN 50569),
- **spin extractors** intended exclusively for industrial purposes,
- **spin extractors** intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas).
