2 Modification to Clause 1, "Scope"

Replace the fourth paragraph including the two dashed items by the following:

This document deals with the reasonably foreseeable hazards presented by appliances and machines that are encountered by all persons.

However, in general, it does not take into account:

- **children** playing with the appliance;
- the use of the appliance by **very young children**;
- the use of the appliance by **young children** without supervision.

It is recognized that **very vulnerable people** can have needs beyond the level addressed in this document.
