With European Amendment A11, EN 60335-2-60:2003+A1:2005+A2:2008+A11:2010+A12:2010 is superseded.

This European Amendment A11, supplements or modifies the corresponding clauses of the standards below:

- EN 60335-1:2012+A11:2014+A13:2017+A1:2019+A14:2019+A2:2019+A15:2021 (Part 1)
- EN IEC 60335-2-60:2023 (Part 2)

2 Modification to Clause 1, “Scope”

Replace the fifth paragraph starting with "As far as is practicable,.. " up to "... children playing with the appliance", by the following:

This document deals with the reasonably foreseeable hazards presented by appliances and machines that are encountered by all persons.

However, in general, it does not take into account:

- **children** playing with the appliance;
- the use of the appliance by **very young children** without supervision;
- the use of the appliance by **young children** without supervision.

It is recognized that very **vulnerable people** may have needs beyond the level addressed in this document.
