This draft amendment (EN IEC 62841-2-6:2020/A12:2024) was prepared by CLC/TC 116 “Safety and environmental aspects of motor-operated electric tools”.

- latest date by which this document has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2024-11-03
- latest date by which the national standards conflicting with this document have to be withdrawn (dow) 2028-05-03

This document modifies by common modifications EN IEC 62841-2-6:2020/A1:2024, which consists of the text of 116/691/FDIS (future IEC 62841-2-6:2020/A1:2024, Ed. 1.0) prepared by IEC/TC 116 “Safety of motor-operated electric tools”.

IEC 62841-2-6:2020/A1:2024, Ed. 1.0 introduces various clarifications for subclause 19.102, Annex I and Annex AA. In addition, subclauses K.21.18.Z101 and L.21.18.Z101 were revised.
