Delete the addition of EN 60335-2-38:2003.

Addition:

This European Amendment A11 supplements or modifies the corresponding clauses of the standards below:

- EN 60335-1:2012+A11:2014+A13:2017+A1:2019+A14:2019+A2:2019+A15:2021+A16:2023 (Part 1)
- EN 60335-2-38:2003+Cor1:2007+A1:2008+A2:2023 (Part 2)

2 Modification to Clause 1, “Scope”

Replace the fourth paragraph starting with “As far as is practicable...”, except Note 102 and Note 103, with the following:

“This document deals with the reasonably foreseeable hazards presented by appliances that are encountered by all persons in and around the installation place. However, in general, it does not take into account:

- **children** playing with the appliance;
- the use of the appliance by **children**;

It is recognized that **very vulnerable people** can have needs beyond the level addressed in this document.”

Add a new bullet point in Note 103:

- “— gas, oil or solid fuel burning appliances (EN 60335-2-102)”

Add the following new paragraphs:

“Additional requirements for appliances with power driven moving parts are given in Annex ZE.

This document does not deal with any specific requirements on noise emitted from these appliances the generated noise is not considered to be a relevant hazard. Thus, the emission sound pressure level L_{pA} is considered to be $L_{pA} \leq 70 \text{ dB(A)}$.”
