INTRODUCTION to Amendment 1

This amendment updates the interpretation of the bit encoding for reporting various cases of AtoN errors or failures to be compliant with the notes available in the IALA R-0126 Ed.2 published in December 2021. The amendment further corrects an inconsistency between Table L.1 of IEC 62288:2021 and Figure 4 section 4.8.4 of IALA Rec.R-0126:2021.

Replace, in Table A.1, row 2.10 a, column "Symbol graphic(s)", under the "Racon err" symbol graphic, the text "Racon error (bits 11111001 or 11111011 or 11111111)" with "Racon error (bits 11111001 or 11111011)".

Replace, in Table A.1, row 2.10 a, column "Symbol graphic(s)", under the "Error" symbol graphic, the text "Light error or combination of light error/off with racon error (bits 11100110 or 11101110 or 11110110 or 11111101)" with "Light error or combination of light error/off with racon error (bits 11100111 or 11101111 or 11110111 or 11111101 or 11111111)".
