### 1 Scope

Replace the two first paragraphs with the following:

"This document specifies the electrical safety requirements for HBES/BACS."

In the third paragraph, delete "network" after "HBES/BACS".

Delete the fourth paragraph and list, which begins: "This document is applicable to...".

Replace the fifth paragraph and list with the following:

"This document covers the following requirements and compliance criteria:

- · protection against hazards from the device;
- protection against overvoltages on the network;
- · protection against touch current;
- protection against hazards caused by different types of network;
- protection of the communication wiring against overheating caused by excessive current."
