Addition:

With European Amendment A11, EN IEC 60335-2-4:2023+A11:2023 is superseded.

This European Amendment A11 supplements or modifies the corresponding clauses of the standards below:

- EN IEC 60335-1:2023+A11:2023 (Part 1) ;
- EN IEC 60335-2-4:2025 (Part 2).

2 Modification to the “Scope”

Replace the text starting with “As far as is practicable...” up to “...that are encountered by all persons” with the following:

“This standard deals with the reasonably foreseeable hazards presented by appliances and machines that are encountered by all persons.”

Add before the fifth paragraph starting with “Attention is drawn to the fact” the following:

“It is recognized that people with disabilities can have needs beyond the level addressed in this standard.”

*In the sixth paragraph starting with “This standard does not apply to...”, replace “appliances” with “**spin extractors**” (two times).*

In the sixth paragraph starting with “This standard does not apply to...”, add the following dashed item:

- **spin extractors** intended to be used in launderettes (EN 50569),
