- for $d_{p,max} \leq 1,00$, the tolerance of d_p has been modified to h13 according to ISO 4753:2011, Table 1, Footnote b;
- for $z_{min} \leq 1,00$, the tolerance of z has been modified to $^{+IT13}_0$ according to ISO 4753:2011, Table 1, Footnote d;
- approximate masses have been deleted in [Table 2](#);
- non-ferrous metal screws have been deleted (as a consequence of the withdrawal of ISO 8839);
- for stainless steel fasteners, “Plain” has been changed to “Clean and bright”, and “Passivated” has been added in [Table 3](#);
- specifications for marking and labelling have been added as [Clause 6](#);
- [Annex A](#) has been added for cut-off slugs at machined set screws with dog point.

Fasteners — Hexagon socket set screws with dog point

1 Scope

This document specifies the characteristics of hexagon socket set screws with dog point, with metric coarse pitch threads M1,6 to M30 for steel and M1,6 to M24 for stainless steel, and with product grade A.

Set screws are not intended for use under tensile load.

If, in certain cases other specifications are requested, hardness classes and stainless steel grades can be selected from ISO 898-5 or ISO 3506-3, and dimensional options from ISO 888, ISO 965-1 or ISO 4753.
